Unless otherwise agreed, Allied Roofing will only perform a visual inspection, and cannot guarantee that no additional problems will be discovered once repair begin. Customer acknowledges and understands that, after Allied Roofing commences its work, new or additional problems may be uncovered that were not discovered by Allied Roofing’s visual inspection and that the price and time to complete the repairs may be increased because of such problems. No consequential or related damages, interior or exterior, are covered under any warranty. Customer further acknowledges and agreed that Allied Roofing is not responsible for damages or leaks to existing conditions or existing sources of leakage simply because Allied Roofing started work or performed repair work.
